ORDER OF TIME AND PLACE OF HEARING, AND FOR
SERVICE OF SUMMONS BY PUBLICATION AND POSTING
ON PREMISES, FOR AMENDING SUMMONS ISSUED, AND
FOR VACATING ORDER OF MARCH 25, 1930.

Upon reading the verified petition of the above named petitioner on file in the above entitled suit, and good cause appearing therefor:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the time and place of hearing the said petition be and the same is hereby fixed as Friday, the 5th day of June, 1930, at the hour of 10 o'clock in the forenoon, before the undersigned Judge of the above entitled Court at his Court Room in the Judiciary Building, Wailuku, County of Maui, Territory of Hawaii; and

IT IS HEREBY FURTHER ORDERED ADJUDGED AND DECREED that notice of the above action shall be given to all persons having or claiming to have any legal or equitable right, title or interest in the land described in said petition whose names are unknown, or who, if known, do not reside within the Territory of Hawaii or cannot for any reason be served with summons, by publication of the summons issued out of the above Court in the above entitled matter in the "Maui News", a newspaper having a general circulation in the above named circuit, once in each of ten successive weeks, the first publication to be on the ~~29th~~ ^{5th} ~~day~~ ^{Maui} ~~clear~~

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that additional notice of the pendency of said action be given by posting copies of said summons in three conspicuous places upon the land described in said summon, such posting to be had at least six weeks prior to the date of hearing; and

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that that certain order of time and place of hearing and for service of summons by publication and posting on the premises made, entered and filed in the above entitled suit on the 25th day of March, 1930 be and the same is hereby vacated, set aside and declared null and of no effect; and

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that the summons heretofore and upon the 25th day of March, 1930 filed and issued out of the above entitled Court in the above entitled suit be amended by the Clerk of this Court by amending the date of hearing as appearing in said summons to read the 20th day of June, 1930 instead of the 23rd day of May, 1930 as it reads at present.
