DECREE DETERMINING CONTEST RAISED
BY ANSWER OF AH CHEEN.

The above entitled matter came on before the Judge of the above entitled Court sitting at chambers in equity on the 18th day of December 1930 at 1.30 o'clock P. M. for the trial of the issue raised by the answer of Ah Cheen filed herein July 17th 1930, R. A. Vitousek of the firm of Smith, Warren, Stanley and Vitousek appearing for the petitioner, Baldwin Packers Limited, and Wendell F. Crockett, appearing for the respondent Ah Cheen, and the respondent Ah Cheen being personally in Court and the said parties consenting thereto and good cause appearing therefor;

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the said respondent Ah Cheen at the date of the filing of the petition in the above entitled matter owned, held and was vested with an undivided one-tenth (.10) of an undivided 1/113th interest in the

land sought to be partitioned in these proceedings and being an undivided one-tenth (.10) of the share in the Hui Mailepai and in the lands owned by said Hui originally owned by Kauwahikaua;

AND IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that the Baldwin Packers Limited, petitioner herein, is the owner of the remaining interest in contest being an undivided four-tenths (.4) of an undivided 1/113th interest in the lands sought to be partitioned in these proceedings and being a four-tenths (.4) undivided interest in the share in the Hui Mailepai and the lands owned by said Hui originally owned by said Kauwahikaua.

AND IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the finding and decrees and orders of this Court contained in the decree of this Court dated July 29th, 1930, shall apply to the undivided interests and to the owner thereof as herein determined.
