DECREE DETERMINING AND AWARDING COSTS.

WHEREAS the judge of the above court in the above suit by decree dated and filed November 21, 1931, among other things, fixed the amount of fees, expenses and court costs that were to be paid, and taxed the same as costs against all of the parties receiving lots or parcels of land under the terms of said decree in proportion to the respective interests owned by the parties entitled to such lots or parcels of land, all of which were to be paid by the petitioner in the first instance but was to be contributed to by all of said parties in said proportion; and

WHEREAS the total of such fees, expenses and court costs was the sum of \$18,243.07, which has been paid by the petitioner; and

WHEREAS the petitioner's share of such fees, expenses and court costs was the sum of \$15,768.85, leaving a balance of \$2,474.22 that should be paid by the remainder of said parties to the petitioner, and
